- Noted that staff are considering using the Temporary Use Permit process as a first step in the agri-tourism process rather than rezoning to the A1(t) zone immediately.

## 7.1 Councillor Sieben, re: Snow Removal on Sidewalks

- Made reference to property owners that have rear sidewalks and the requirement for property owners to clear snow.
- Suggested that Council needs to look at the City Policies with respect to snow removal and grass cutting.
- Inquired if enforcement of snow removal and grass cutting is a priority for Bylaw Enforcement staff.

City Manager:

- Staff will need to look at the history of the number of complaints, who originated them and where they are located.
- Council is able to change the Policy, but will first need to know the budget and any other broader implications.
