#### Recommendation:

THAT Council receive, for information, the Report from the Office of the City Clerk dated April 19, 2021 regarding outstanding Council directives from Q1, 2021.

#### Purpose:

To provide Council with a list of the outstanding Council directives from the first quarter of 2021.

#### Background:

This is the first of what will be quarterly updates to Council regarding Council directives from the previous three months. Those directives still outstanding are identified, and a status update provided for each as appropriate. As this has not been done on a regular basis, all outstanding Council directives from this Council term are included.

Council directives are resolutions adopted by Council directing staff to respond in some manner. Most are initiated by Council members, as opposed to being part of a staff report to Council. Sixty-one (61) Council service requests were created from the beginning of the Council term to March 31, 2021, 52 of which have been completed.

#### Discussion:

Open Meeting Council directives prior to January 2021 are as follows:

1. Business Licence Bylaw; Cannabis Regulation Bylaws

COUNCIL RESOLUTION FROM THE DECEMBER 10, 2018 PM MEETING:

THAT Council receives, for information, the report from the Business Licencing Manager dated December 10th, 2018 with respect to proposed draft regulations for the development of a Cannabis Retail and Cannabis Related Business Licence Bylaw.

AND THAT Council directs Staff to bring forward Business Licence Bylaw amendments in line with the report from the Business Licencing Manager dated December 10th, 2018;

AND THAT Council directs Staff to bring forward Bylaw Text amendments for the Medical Marihuana Producer Business Licence and Regulation Bylaw No. 10920 as outlined in the report from the Business Licencing Manager dated December 10th, 2018.

Development Services staff continue to work through the drafting of these bylaws and anticipate bringing them forward to Council later this year.

#### 2. <u>Inclusivity</u>

COUNCIL RESOLUTION FROM THE MONDAY, JUNE 19, 2019 AM MEETING: THAT Council direct staff to hold a Monday AM Open workshop regarding ways to promote inclusivity as a Council policy

The above resolution was adopted following a discussion regarding amending the Council Flag Policies to include flying the Pride Flag. The City and key stakeholders have been actively implementing actions identified in the Community for All Action Plan since its endorsement in December 2016 and have reported outcomes as part of the annual Council Priorities progress report. In 2021-2022 staff are undertaking a diversity strategy, which will include a Council discussion per the resolution.

#### 3. Anti-Idling Bylaw

COUNCIL RESOLUTIONS FROM THE MONDAY, FEBRUARY 10, 2020 AM MEETING:

THAT Council direct staff to confirm the status of a Regional Anti-idling Bylaw and report back to Council.

AND THAT Council direct staff to investigate options to regulate anti-idling including number of complaints, pros and cons of enforcement and report back to Council.

Transit & Programs (Regional Programs) staff have investigated the merits and challenges of an antiidling bylaw and are preparing a response.

#### 4. Council Meeting Policies

COUNCIL RESOLUTION FROM THE MONDAY, OCTOBER 19, 2020 AM MEETING: THAT Council direct staff to investigate and bring forward policies to ensure appropriate conduct when in Council Chambers and corresponding to Council

Office of the City Clerk and Risk Management staff began work on reviewing and updating existing bylaws, policies and procedures. Work has been delayed due to other priorities and the current prohibition of the public from attending Council meetings and public hearings, as per Public Health Orders.

#### 7. Water Maintenance

Water Operations and Communications staff are completing an engagement plan with the impacted customer group to be implemented in late April.
