Purpose:

To update Council meeting and public hearing procedures under Phase 3 of BC's Restart Plan.

Background:

BC moved into Phase 3 of its Restart Plan on July 1, 2021 and the Provincial Health Officer (PHO) Order on Gatherings and Events was revised. This increased the capacity for in-person attendance at Council meetings and public hearings to the greater of 50 people or 50% of seating capacity, excluding Council and staff. Restrictions regarding contact information, physical distancing, cleaning and sanitizing, and prohibiting contact between event participants were also lifted.

Council previously passed several resolutions modifying Council meeting, public hearing, and development application processes during the COVID-19 pandemic, as noted in the following tables.

Discussion:

Council Meetings & Public Hearings

The public can now attend open Council meetings and public hearings. With 50% of seating capacity in Council Chambers, up to 67 members of the public can be present, in addition to Council and staff. Restrictions on and requirements for in-person attendance include:

- Maximum of 67 members of the public present;
- Seating must be available for each participant, seating must use all available space, and participants must remain seated unless presenting to Council; and
- Hand sanitation supplies must be available.

The July 13 public hearing and Tuesday regular meeting will be conducted electronically in accordance with Council's direction on June 28. To meet required timelines, statutory notices and advertising was sent before the Province announced the move to Phase 3 of the Restart Plan.

Council previously directed the July 27 public hearing and Tuesday regular meeting to be conducted both electronically and with the public present. Staff recommend this hybrid approach continue throughout Phase 3 or until Council provides long-term direction on hybrid public hearings. The revised PHO Order allows for more members of the public to attend in-person and removes the need for staff to gather contact information. The potential need for an auxiliary site to increase capacity is less likely. Additional staff are still needed to moderate the Teams meeting and operate the camera system at an estimated cost of \$500 per public hearing.

Council has waived 24 public hearings since January 2021 with eight (8) pieces of correspondence submitted on five (5) or 21% of those s. Another 53 applications have been forwarded to public hearing in that same time. During Phase 3 of the Restart Plan, staff recommend that Council continue to direct staff to recommend public hearings be waived for rezoning applications that are consistent with the Official Community Plan, have a recommendation of support from staff, and are not expected to generate significant public interest. This is consistent with Council's authority under the *Local Government Act*. The public can submit correspondence to Council on items where the public hearing has been waived and staff prepare a supplemental report to Council. Staff will bring forward options to revise <u>Council Policy No. 307 Waiver of Public Hearings</u> along with long-term options for electronic Council meetings and public hearings.

Early in the pandemic, Council directed that the requirement for face-to-face interactions between applicants and the public be waived until the PHO Order on Gatherings and Events is lifted. Staff recommend this remain in effect. Applicants may still choose to conduct face-to-face consultation or hold in-person information sessions in accordance with the PHO Order.

Council also directed that public hearings be scheduled with specific start times and as early as 4 pm. This is in effect until the PHO Order on Gatherings and Events is lifted. Long-term approaches for scheduling public hearings will be considered with the options for electronic Council meetings and public hearings.

Committees

The Agricultural Advisory Committee will conduct hybrid meetings following Council's direction on June 28. Committee meeting procedures will be considered when staff report back to Council on long-term options for Council meetings and public hearings.

Next Steps

The ability to conduct Council meetings and public hearings was initially a temporary measure introduced during the COVID-19 pandemic. The Province has now amended the *Community Charter* to allow for Council meetings and public hearings to be conducted electronically going forward. After reviewing the legislation and guidance documents, staff will present a report to Council this summer with options for electronic participation by Council and the public, waiving public hearings, public hearing scheduling, and committee meetings. Once Council provides direction on a preferred option, staff will bring forward any necessary amendments to Council Procedure Bylaw No. 9200.

Conclusion:

Phase 3 of BC's Restart Plan allows for greater capacity for public attendance at open Council meetings and public hearings. A hybrid approach for public hearings and Tuesday regular meetings lets the public choose whether electronic or in-person participation is best for them as we transition away from COVID-19 restrictions.

Staff will report back to Council with long-term options for electronic Council meetings and public hearings following the changes to the *Community Charter*.



Key Conditions


- Cumulative maximum of 50 people or 50% seating capacity

- Council Chambers seating capacity now 67 persons, excluding Council and staff





Monday Council Meetings


- Rare for 67 person maximum to be achieved
- Applicants with a non-support will be able to address Council directly





Public Hearings & Tuesday Regular Meetings

- Public hearings will combine in-person and virtual public participation beginning July 27
- Challenge meeting conditions:
 - Maximum of 67 people in Chambers
 - May require additional venue for some applications
 - Hybrid hearing & meeting procedures need to be drafted

Recommendation:

THAT Council receives, for information, the report from the Chief Election Officer with respect to the 2021 School Trustee By-Election results and ballot account report.

Purpose:

To report on the final results and ballot account for the Central Okanagan Public Schools 2021 School Trustee By-Election.

Background:

The City of Kelowna conducted a by-election on behalf of the Central Okanagan Public Schools (School District No. 23). The by-election was to fill a vacancy for one trustee for the remainder of the 2018-2022 term. The attached Declaration of Official Results and Ballot Account is submitted to Council as required under the *Local Government Act*.

Discussion:

General voting day was Saturday June 26 and two advance voting opportunities were held on Wednesday June 16 and Wednesday June 23. Four voting locations (Dr. Knox Middle School, Kelowna Secondary School, Okanagan Mission Secondary School, Rutland Senior Secondary) were available on general voting and advance voting was held at the Hollywood Road Education Centre. Voters also had the option to vote by mail ballot.

A total of 2,042 residents cast their vote for school trustee. This represents 1.85% of the estimated 110,175 eligible voters.

To conduct the by-election, 54 individuals were hired and trained as Presiding Election Officials, Alternate Presiding Officials, and Election Officials. Their training focused on maintaining the integrity

of the registration and voting process, the secrecy of the ballot, and the principles of fairness, accessibility, and awareness.

COVID-19 safety plans and procedures supported our commitment to keeping voters, candidates, and election staff safe during the pandemic. Protective measures included physical distancing, requirements to wear a mask, capacity limits, barriers and personal protective equipment, hand sanitizing stations, signage, frequent cleaning, and health checks. Mail ballot voting and curbside voting provided alternatives for those who were otherwise unable to enter a voting place.

Following the posting of unofficial results at the close of voting on June 26 and the determination of final results on June 30, the official results were declared on Wednesday June 30, 2021.

Conclusion:

Staff are completing the post-vote requirements for the by-election, including a review of the byelection successes, challenges, and opportunities for future election planning. Staff will begin planning for the 2022 General Local Election later this year.

Local Government Act s. 158(1)

Within 30 days after the declaration of official election results under section 98 for an election by acclamation or under section 146 for an election by voting, the chief election officer must submit a report of the election results to the local government.

Financial/Budgetary Considerations:

Under the *School Act*, the School District is responsible for reimbursing the City for costs incurred to conduct the by-election. Costs are being determined and an update will be provided during the staff presentation.
