- Made comment that the proposed application is consistent with the current Official Community Plan as well as the draft 2040 Official Community Plan.

### Shauneen Hicks, Fleming Road

- Made reference to previously submitted correspondence.
- Raised concerns with child and community safety due to vehicle congestion.
- Raised concerns with on street parking.
- Raised concern that access to and from her own property is being blocked.
- Opposed to this application.

## Glen Hicks, Fleming Road

- Raised concern with on-street parking and parking close to or blocking driveways in particular.
- Raised concern with the lack of on-site parking.
- Referred to the nearby empty lot that is being used for parking and raised concerns with implications when that particular lot is developed.
- Opposed to this application.

# Aoife O'Neill, Ladner Road, Property Manager

- Licensed Property Manager that represents owners of Urban Park Townhomes.
- Acknowledge there are some issues within the complex and are working to resolve them.
- Recognize that some tenants are using their garage space for other purposes.
- Spoke to on-site parking challenges and commented that tandem parking style is not unique.
- Suggested that on-street parking could be regulated with time restrictions by the City to encourage tenants to use their garages.
- Represent all 36 units and mindful of tenant mix with no more than 4 tenants per unit and 2 cars per unit.
