Purpose:

To receive an overview of the recently launched Urban Centres Dashboard.

Council Priority Alignment:

Affordable Housing Economy Climate and Environment Transportation

Background:

The Thriving Urban Centres project (formerly called the Urban Centres Framework) aims to provide a new, more resource efficient approach to neighbourhood planning for Kelowna's five Urban Centres: Downtown, Pandosy, Capri-Landmark, Midtown and Rutland. Funded largely through a Union of BC Municipalities (UBCM) Complete Communities grant, the project aims to provide more responsive guidance sooner with more real time data than can be achieved in a traditional Urban Centre plan.




Figure 1: Thriving Urban Centres project timeline

Launched in late 2023 with the approval of the UBCM grant, the Thriving Urban Centres project is nearing completion, and the following three key deliverables will be completed by this summer as illustrated in Figure 1:

- 1. A trends report outlining the status of our Urban Centres complete
- 2. An interactive online mapping and **dashboard** tool to assist with future decision making -today; and
- 3. A report on future directions to make Kelowna's Urban Centres thrive- later this summer.

Previous Council Resolution

Discussion:

To support the development of Kelowna's Urban Centres, it is necessary to ensure a high quality of life for residents and create attractive locations for visitors and workers. Esri Canada has been engaged to assist in developing the <u>Urban Centres Dashboard</u> to enhance and modernize the City's data-driven decision-making. This dashboard provides a comprehensive overview of each of the five Urban Centres, covering aspects such as population, housing, daily needs, transportation, climate and environment, and future directions. It is powered by data from Model City, BC Assessment, Environics, and other City data sources, offering accessibility to Council, staff, and the public through an interactive interface. This method addresses Kelowna's growth challenges by providing access to real time information, enabling faster adaptation to new changes, and reduces the need for developing plans from scratch by updating future directions promptly, reinforcing our "City of the Future". Dashboard users will find data on these subjects under a series of easy to use tabs:

- Housing includes information on existing and upcoming residential units, housing types, housing tenure and anticipated units by 2041.
- Population shows current population, population by age bracket, annual income, indigenous identity and visible minority.
- Employment shows the estimated number of jobs in each Urban Centre as well as business licenses and BC Assessment land uses.
- Amenities and Environment provides information about schools, daycare capacity, parks and trees.
- Infrastructure and Transportation provides information about age of all buildings, bike infrastructure, shared use pathways, sidewalk completeness, and modal split.
- Capital Projects provides information on the capital projects underway in each Urban Centre.

The dashboard also includes a variety of mapping layers with locational information on building permit and development applications, capital projects, business licenses, parks, street trees, zoning, building heights, street character, bus routes and more.

The Urban Centres Dashboard is anticipated to evolve over time. Future updates could include new measures and directions coming out of Urban Centre Action Planning and the integration of new data as it becomes available.

Next steps:

Now that the Trends Report, Urban Centres engagement, and Dashboard are complete, staff are focusing on other parts of the Thriving Urban Centres project.

- **Urban Centres Future Directions Report:** This final report to meet the commitments of the UBCM grant is targeted for completion by summer 2025. It will outline proposed new policy directions alongside actions that are necessary to continue to grow Urban Centres into complete communities. The Future Directions Report will be informed by the Trends Report, the Dashboard, community engagement and additional analysis work including:
 - Growth projections: The revised growth scenario (presented to Council at the April 14, 2025 PM session) which demonstrates that based on the existing zoned capacity the five Urban Centres, are well poised to accept a significant share of our city's growth.
 - Employment projections: An analysis is being completed to understand the types and amount of employment growth that can be anticipated in each Urban Centre. This work also includes research to examine future potential employment densities and will consider policy options to support Urban Centre employment growth. This work is being coordinated with the outcomes of the recently released Regional Employment Lands Inventory by RDCO.
- **Urban Centre Action Plans** (to be completed post project): The Thriving Urban Centres project will be used to inform future Urban Centre Action Plans. These Action Plans will focus on nimble implementation tools that can help the City respond to the evolving growth context of each Urban Centre. The key directions identified in these Action Plans would be included in future updates of the Urban Centre Dashboard.

Conclusion:

Kelowna's Urban Centre planning adapts to intensive urban growth and high demand. The Urban Centres Dashboard streamlines the process, efficiently using staff resources and incorporating datadriven decisions with community input through tools like Model City.

 - Transportation: The Urban Centres Dashboard will inform upcoming transportation projects.
 - Climate and Environment: Urban Centre planning will explore opportunities to make our Urban Centres low-emission and more resilient to the effects of climate change.
 - Economy: Urban Centre planning allows for a strategic approach to growing employment in Kelowna's busiest activity hubs.

Financial/Budgetary Considerations:

The City has received \$149,500 of grant funding from the Complete Communities Program, administered by the Union of BC Municipalities (UBCM) to assist with this process. These funds supplement the \$75,000 of annual funding for Urban Centre Planning identified in the Long Range Planning base budget.




Urban Centres Dashboard -Thriving Urban Centres




