## 6.1 124-948 McCurdy Rd, LL16-0016 - Victor Projects Ltd

Councillor DeHart declared a conflict of interest as a colleague of the Ramada Hotel is married to a principle of Victor Projects Ltd and due to the location of Mickey's Pub on the Ramada premises departed the meeting at 8:49 p.m.

Letter in Favour Additional information from the Applicant

Mayor Basran invited anyone in the public gallery who deemed themselves affected to come forward, followed by comments of Council.

#### Merlin Brunage, Christ Brunage and Don MacLaughlin, Applicant

- Spoke to their good record with the Liquor Control Board over the past several years.
- Provided reasons why a 2:00 a.m. opening time is being requested and believes this extra time would not put a strain on RCMP resources.
- Would like to have the extra hour opening for business model flexibility in the future.
- Their business is located closer to the UBCO Campus and will provide a less expensive cab ride to and from the establishment than from UBCO and downtown.
- Spoke to the industrial setting of the neighbourhood and that just a few blocks away is residential neighbourhoods.
- Advised that historically there have been no calls to the RCMP other than for vehicle break ins.
- Responded to question's from Council.
