Subject: Budget Adjustments Required for Sanitary Replacement Projects – Lane North of Fuller

Recommendation:

THAT Council receives for information, the report from the Infrastructure Division Director dated July 16, 2018 regarding the budget adjustments required for the Lane North of Fuller Sanitary Replacement, Lane North of Stockwell Sanitary Replacement and Lane North of Martin Sanitary Replacement;

AND THAT the 2018 Financial Plan be amended to reflect the addition of up to \$400,000 budget from the Sanitary Sewer Utility to the above mentioned Sanitary Replacement Capital projects;

AND FURTHER THAT Council authorize the additional expenditures totaling up to \$400,000 for these sanitary replacement projects as outlined in this report.

Purpose:

To transfer budget from the Sanitary Sewer Utility, to meet expected financial commitments for the Lane North of Fuller Sanitary Replacement, Lane North of Stockwell Sanitary Replacement and the Lane North of Martin Sanitary Replacement projects.

Background:

A number of City capital projects have experienced higher than anticipated tender submissions this past year, as local contractors are busy with development servicing and other capital works in the region. Tender pricing has risen as much 30% in some cases. As a result, cost estimates for current tenders being planned are higher than current available budgets. However, the projects are necessary to keep up with infrastructure renewal demands. These three sanitary sewer replacement projects will be tendered together as a package and will include a flexible completion schedule to best attract competitive tender pricing. City crews are not available to complete these projects due to higher priority commitments.

To proceed with the tender requisition, additional budget is being requested to meet the current tender cost estimate with increased contingency to reflect current industry cost escalation. Once the tender is awarded the amounts will be adjusted to reflect actual tender costs.



The budget shortfall for the three projects is estimated at \$400,000.

The following budget amendments are required to meet current projections.
