Purpose:

To amend various City of Kelowna Bylaws to update wording to reflect the proposed repeal of City of Kelowna Zoning Bylaw No. 8000 to be replaced with City of Kelowna Zoning Bylaw No. 12375.

Background:

City of Kelowna Zoning Bylaw No. 8000 is proposed to be repealed and replaced by City of Kelowna Zoning Bylaw No. 12375. As such, a domino effect has prompted changes in various other City of Kelowna Bylaws that reference the old Zoning Bylaw No. 8000. These changes will align the wording, zone codes, and references with the new Zoning Bylaw No. 12375.

Discussion:

- A. Schedule A Building Bylaw No. 7245: The current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375.
- B. Schedule B Animal and Poultry Regulation and Animal Pound Bylaw No. 5421-82: The current wording references Zoning Bylaw No. 8000 and specific zones that are proposed to be deleted and replaced with Zoning Bylaw No. 12375.
- C. Schedule C Business Licence and Regulation Bylaw No. 7878: The current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375.
- D. Schedule D Subdivision, Development & Servicing Bylaw No. 7900: The Schedule 1 Table references zones which are proposed to be repealed and replaced by Zoning Bylaw No. 12375. Development Planning Staff worked with Development Engineering Staff to ensure that proposed changes align with the intent and requirements of the Servicing Bylaw. Table 1 is proposed to be removed and replaced.
- E. Schedule E Building Numbering Bylaw No. 7071: The current wording references Zoning Bylaw No. 8000 and specific zones that are proposed to be deleted and replaced with Zoning Bylaw No. 12375.

- F. Schedule F Revitalization Tax Exemption Bylaw No. 9561: The current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375.
- G. Schedule G Good Neighbour Bylaw No. 11500: The current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375.
- H. Schedule H Soil Removal and Deposit Regulation Bylaw No. 9612: The current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375.
- I. Schedule I Short-Term Rental Accommodation Business License and Regulation Bylaw No. 11720: The current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375.
- J. Schedule J Traffic Bylaw No. 8120: The current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375.
- K. Schedule K Payment in Lieu of Parking Bylaw No. 8125: The current wording references language in the repealed Kelowna 2030 Official Community Plan Bylaw No. 10500 that has been replaced by Kelowna 2040 Official Community Plan Bylaw No. 12300. In addition, the current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375.
- L. Schedule L Development Application Fees Bylaw No. 10560: The current wording references Zoning Bylaw No. 8000 and specific zones that are proposed to be deleted and replaced with Zoning Bylaw No. 12375. In addition, the fees for Temporary Sign Permits have been corrected to be consistent with number of days across the board.
- M. Schedule M Bylaw Notice Enforcement Bylaw No. 10475: The current wording references Zoning Bylaw No. 8000 and is proposed to be replaced with Zoning Bylaw No. 12375. In places where the regulation has been removed from Zoning Bylaw No. 12375, the regulation is also proposed to be removed from the Enforcement Bylaw.

Conclusion:

Development Planning Staff are recommending support for the proposed Bylaw Amendments to various City of Kelowna Bylaws to align with City of Kelowna Zoning Bylaw No. 12375.
