THAT Council approves the City's renewal of a 5-year contract with Regional District of Kootenay Boundary (RDKB) to provide fire dispatch services in the form attached to the Report of the Fire Chief dated and,

THAT Council approves the City's renewal of a 5-year contract with Okanagan Indian Band (OKIB) to provide fire dispatch services in the form attached to the Report of the Fire Chief dated and,

AND THAT the Mayor and City Clerk be authorized to execute all documents associated with these transactions.

#### Purpose:

To request approval by Council to continue providing fire dispatch service to the VFR, RDKB and OKIB on a fee for service basis for another five years.

## **Background:**

The Kelowna Fire Department has worked collaboratively with these three customers of Fire Dispatch to renews the existing contracts for a further five years. The attached contract amendments were presented to their respective boards for endorsement and were each approved. With Council's endorsement of these contracts, staff will continue to dispatch for VFR, OKIB and RDKB for five more years staring January 1<sup>st</sup>, 2023.
