3.1 Organics Collection Expansion Update

Councillor Singh joined the meeting at 8:01 a.m.

Staff:

- Displayed a PowerPoint Presentation.
- Commented that today's presentation serves as an information gathering session for the RDCO, on the proposed organic waste collection expansion offered to the Central Okanagan and the City of Kelowna.
- Introduced staff from the Reginal District of Central Okanagan.

Cynthia Coates, Supervisor Solid Waste Services, RDCO:

- Continued displaying the PowerPoint Presentation.
- Commented that the purpose of the presentation is to provide results to date from the food waste engagement and to receive additional feedback from Council.
- Spoke to the timeline of their Food Waste Feasibility Study and public engagement phases for curbside food waste collection.
- Spoke to current management of food and yard waste for single family homes.
- Spoke to four collection options for food waste from residents considering various parameters such as financial, environmental, social, policy alignment and risk.
- Spoke to the results of the surveys and noted overall support for bi-weekly garbage and weekly
 organics; with concerns related to cost, wildlife and transfer station considerations.
- Spoke to the curbside collection preliminary service model and working through concerns such as wildlife, managing odours and extra garbage for large producers.
- Commented on next steps and timeline.
- Responded to questions from Council.

Staff:

- Continued displaying the PowerPoint Presentation.
- Spoke to the impacts on waste collection, the landfill and composting operations.
- Commented that multi-family or commercial food waste has not yet been addressed.
- Responded to questions from Council.
