FOCUS ON SHORT-TERM PARKING





Focus on excellent short-term parking management to support higher turn-over while maintaining a governing role in long-term parking solutions

- Introduction of pay parking will encourage short-term use of on-street spaces and support use of off-street capacity at KGH for longer-term parking
- Land use review will consider future off-street parking needs based on predicted growth



SELF-FUNDED SYSTEM



The parking system will continue to pay for itself (will operate under a user-pay cost recovery model)

 Pay parking in the Hospital area will fund operational expenses with net revenues directed to the South Pandosy Parking Reserve. Reserve funds support future parking equipment, land and infrastructure investments

CUSTOMER SERVICE AND FAIRNESS





Focus on customer service and fairness in parking practices by providing options, technologies and information

- Street frontages adjacent to the hospital will be changed to hourly pay parking and the existing 2-hour time limit will be removed. This will allow for visitor parking longer than 2-hours while ensuring that turnover of vehicles is achieved
- Multi-space pay stations, operating in Pay by Licence mode, supported by PayByPhone, will offer multiple payment options







The City will work with institutions, businesses and developers to plan solutions for parking management

- Consultation with Interior Health revealed that on-site parking at Kelowna General Hospital is under-utilized in the evenings, overnight and on weekends
- Implementation of a new overnight Resident Only Parking restriction will encourage greater use of available on-site parking



SUPPORT A BALANCED TRANSPORTATION SYSTEM



Parking will be used to support a more balanced transportation system

- Pay parking and overnight restrictions will help to encourage increased use of transit, carpooling, walking and cycling, when possible
- A number of improvements to transit routes servicing the hospital have been made and will continue as demand/ridership warrants


Enhanced/modified parking restrictions







HOSPITAL AREA ON-STREET PARKING PLAN

Proposed Parking Strategy

Pay Parking 24/7

Pay Parking 8am-8pm Daily (Unrestricted 8pm-8am)

Daily 1 Hour 8am-8pm, RPO 8pm-8am

Resident Parking Only

Daily 1 Hour Parking - 24/7

Daily 2 Hour Parking 8am-8pm (Expansion)

■ ■ No Parking (Existing Restrictions)




ROYAL AVE



- Hospital frontage pay parking
 - Improve turn over and increase availability of short-term parking near KGH Emergency
 - Allow patient/visitor parking longer than 2 hrs


Increase opportunities for street cleaning & maintenance



ABBOTT ST & ROSE AVE



- ► Hospital frontage pay parking 8am 8pm
 - Improve turnover and increase availability of short-term parking near KGH during peak hours
 - Un-restricted evening and overnight parking opportunity in nonresidential area



OVERNIGHT RESIDENT ONLY PARKING



- Resident Only parking on residential blocks closest to KGH from 8pm to 8am
 - Ensure residents with permits have access to parking in close proximity to their residence in the evening and overnight
 - Reduce impact of 24/7 hospital operations on surrounding residential area
 - Encourage use of available parking on the KGH campus in the afternoon, evening and overnight periods
 - Re-assess one year following implementation to determine if modifications to RPO restriction or area are required



COUNCIL POLICY 366

- Resident Parking Permit Program Administration
- Proposed Amendments
 - New process and criteria to consider requests for Resident Parking Only restrictions
 - Clarification on petition process and what properties may be included/counted
 - After implementing a restriction, a minimum of 18 months required before further requests will be considered
 - Allow temporary permits to be issued for construction vehicles working at unoccupied permit eligible residences





- Multi-Space Pay Stations
- ► Coin & Credit Card Payments
 - Swipe and Tap Options Available
- ▶ Pay by License Plate
 - ► Time savings no receipt to display
 - Eliminates physical permits
- ► AutoVu for Efficient Compliance







MOBILE PAYMENT

- PayByPhone now available at all City operated pay parking locations
- ▶ No service charges
 - ▶ Pay the same rate using a meter or PayByPhone
- ► Add time without returning to vehicle








EXISTING ONE HOUR PARKING
